

The Board of Elections of Wayne County, Ohio, issues this Proclamation and Notice of Election.




Notice of Special Election





Notice of Election on Proposition¹

Notice of Election on Tax Levy in Excess of the Ten Mill Limitation¹




Notice is hereby given that in pursuance of a Resolution of the Board of Education of the Rittman Exempted Village School District of Rittman, Ohio, passed on the 6th day of December, 2023, there will be submitted to a vote of the people at the Primary Election to be held at the regular places of voting on Tuesday, the 19th day of March, 2024 the question of levying a tax, in excess of the ten mill limitation, for the benefit of Rittman Exempted Village School District for the purpose of general permanent improvements.

Tax being a renewal of an existing tax at a rate not exceeding 3.5 mills for each \$1 of taxable value, which amounts to \$43 for each \$100,000 of the county auditor's appraised value, for five years. The estimated annual collection of this levy is \$188,000.

The polls for the election will be open at 6:30 a.m. and remain open until 7:30 p.m. on Election Day.
